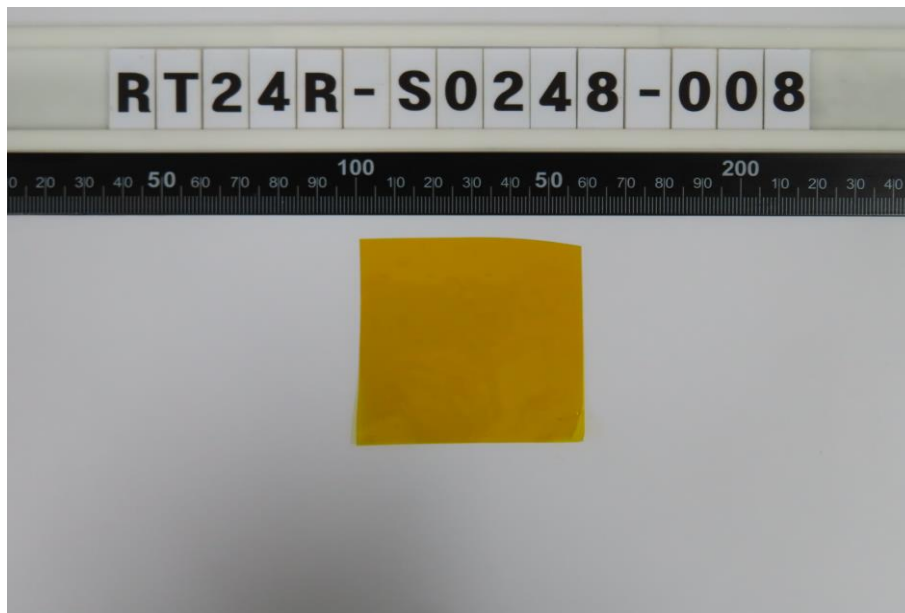

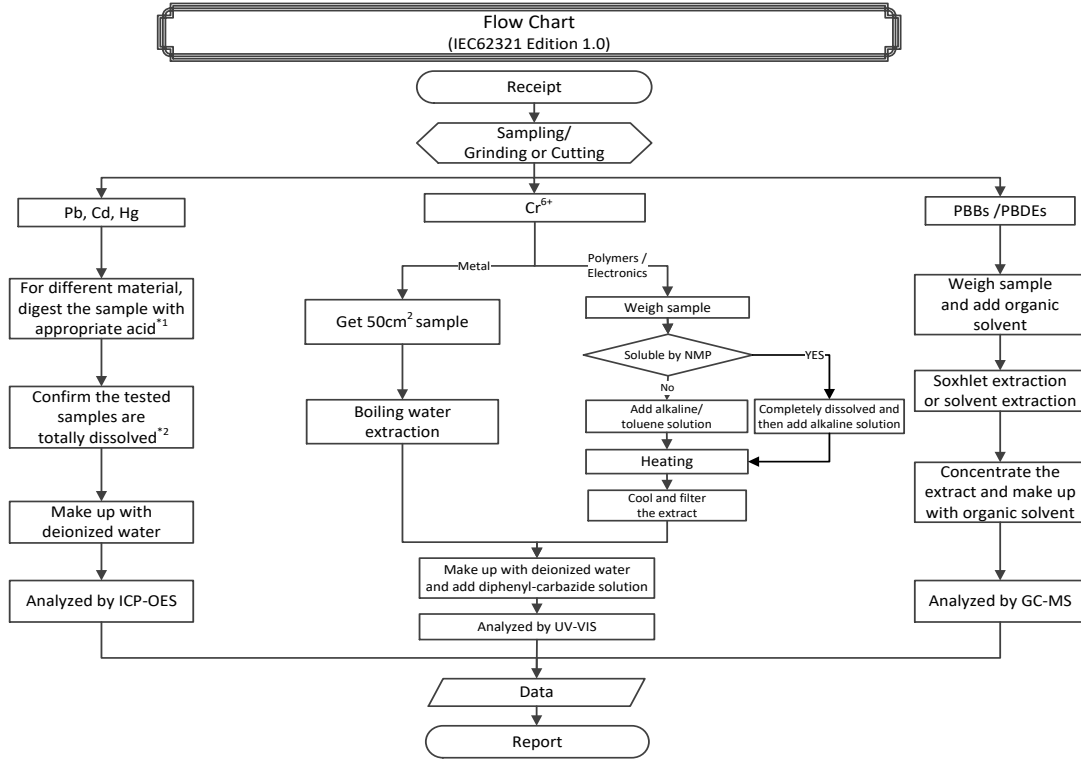

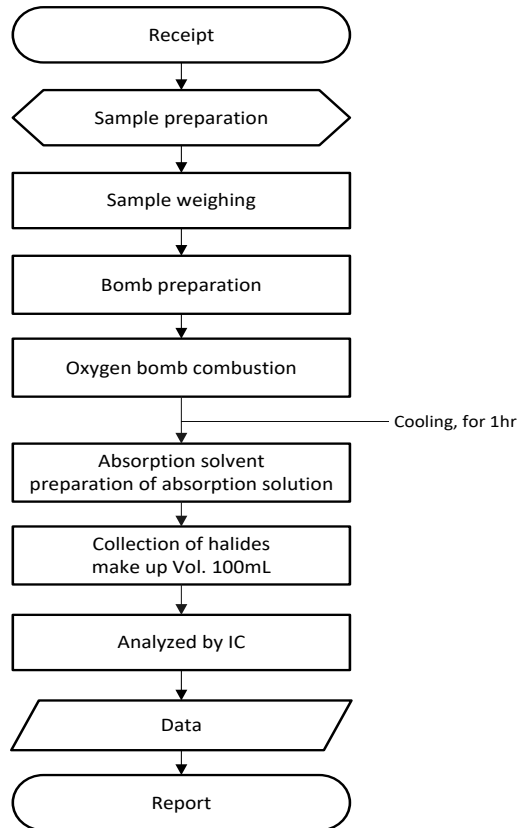

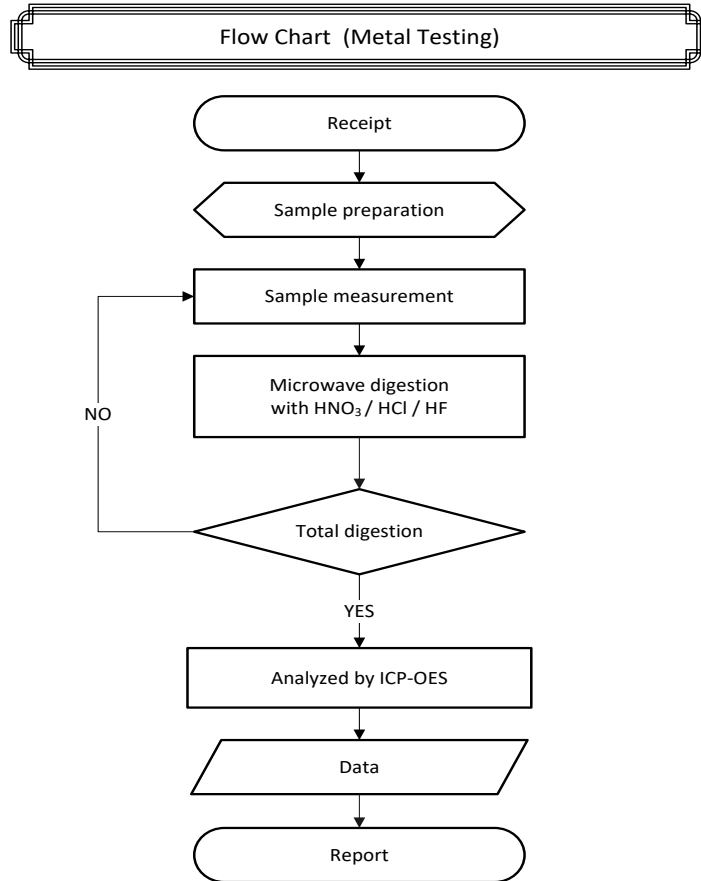
Flow Chart (EN14582)

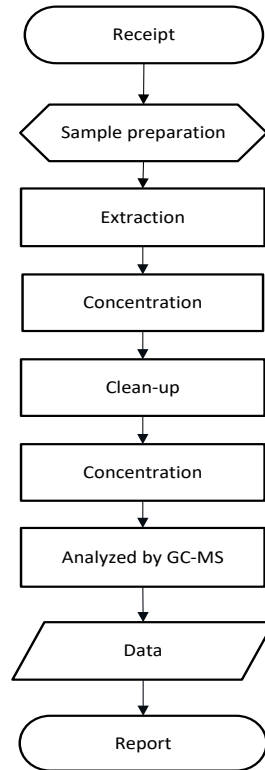
