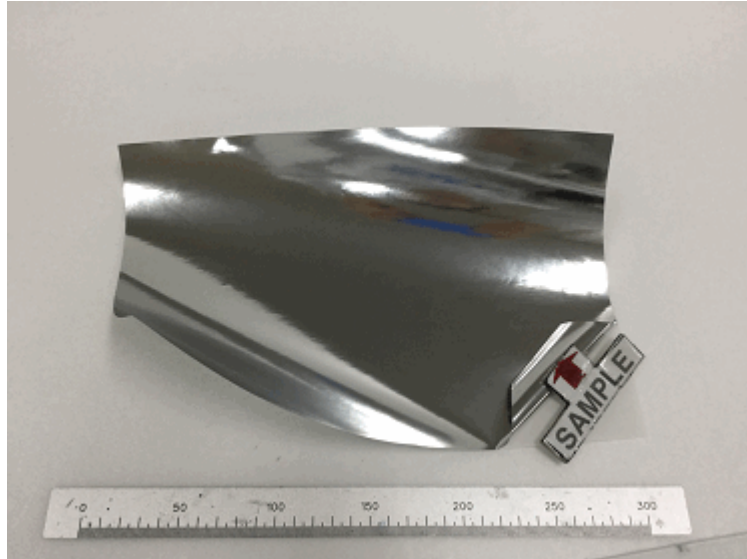

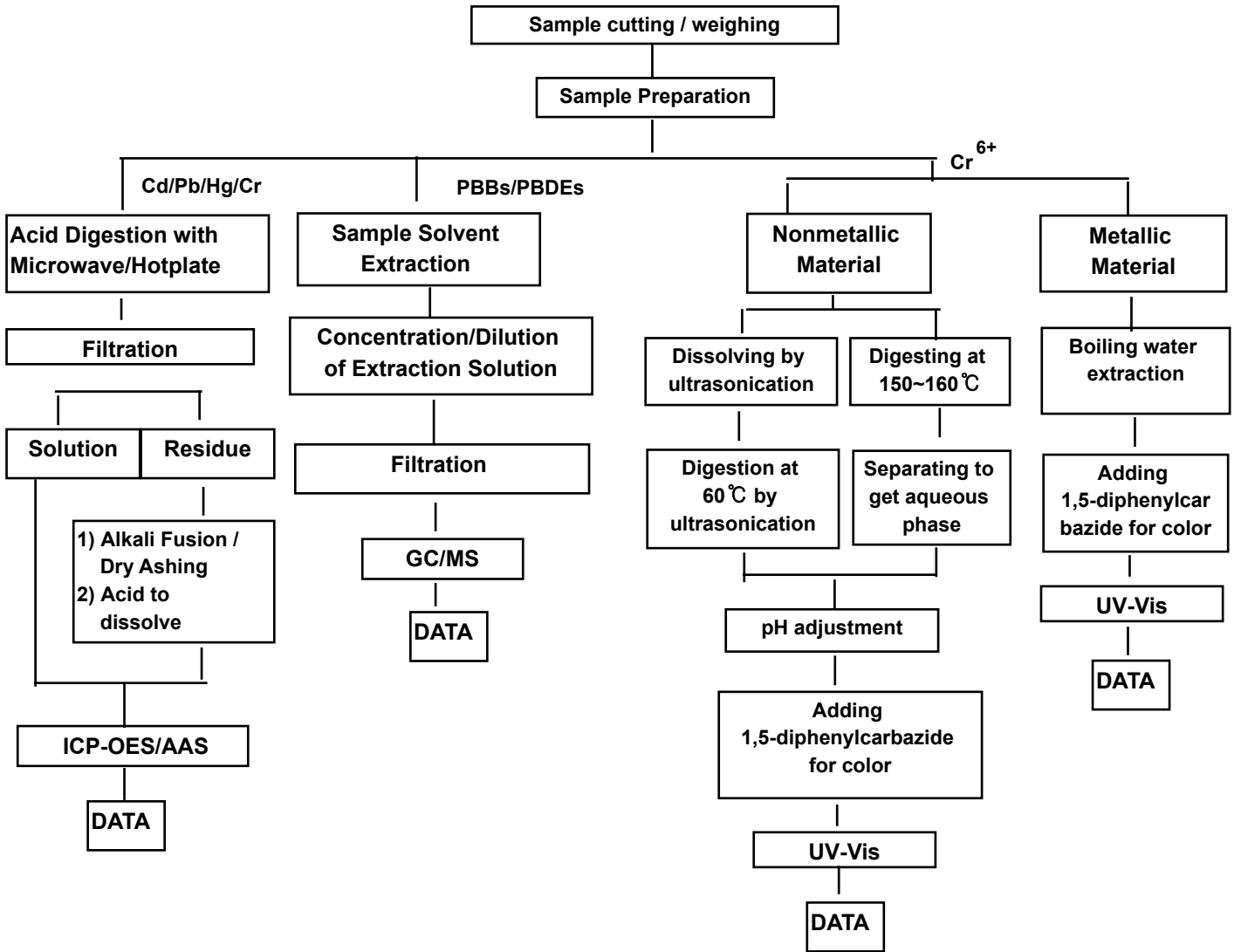
Picture of Sample as Received:
